
- 1) The tenure of the Committee is for two years w.e.f. 21/09/2022.

**Terms of Reference:**

- 1) To ensure implementation of reservation of 5% of seats in the University in terms of Section 32 of the Rights of Persons with Disabilities Act, 2016;
- 2) To formulate mechanism for orientation and sensitization at University level regarding rights of persons with Disabilities (PWDs) in terms of Section 39 (2) (d); and to ensure that the rights of PWDs are included in the curriculum in University in term of Section 39 (2) 9 (f);
- 3) To ensure providing inclusive education to children/students with disabilities in terms of the provisions of Chapter III of the PWD Act, 2016;
- 4) To ensure implementation of other provisions of the Rights of Persons with Disabilities Act, 2016.
