1. The e-Governance Implementation Cell will operate from the Admin. CC office at the Administration Building.

- 2. The above cell will deal with A-Z aspects of management and implementation of the Samarth ERP, existing e-Gov modules and CTT; including onboarding of the modules, regular liasoning with the stakeholders and the Samarth team, training of the stakeholders, troubleshooting, technical administration etc., and handhold the entire process of migration of Student Life cycle and other Administrative and Finance Modules to the Samarth ERP.
- 3. Mr. M.S. Chakravarthy will be the overall In-charge of the cell. In addition, he will be the Nodal Point of Contact of the existing e-Governance modules. He will regularly report the progress of Samarth Implementation to the Chairman SAMARTH ERP Committee.
- 4. Ms. Y. Aravinda will be the Officer in-charge for the modules of the Samarth ERP for CE's Office, Registrar's Office and all CTT related activities in coordination with the CE/DR (A&E)/DR (E-I)/DR (E-II) and the CTT Committee respectively. In addition, she will also take care of her regular responsibilities in the CE's office.
- 5. Mr. Sathya Srinivas will be the Officer in-charge for SAMARTH Implementation at the University level for all the Administrative and Finance modules and Management of ERNET Accounts and other assignments given by Nodal Officer, SAMARTH.
- 6. In addition, the team will also provide technical support for conducting Video Conferencing/Online Meetings, Trainings, etc. as and when required by O/o Vice Chancellor, O/o Registrar and other Statutory bodies.
- 7. The Nodal Officer SAMARTH may ensure setting-up of the Cell and initiate its functioning at the earliest and submit a compliance report to the Registrar before 30.12.2022. He may explore the possibility of mobilizing required number of desktops for setting up of the cell.
