The Non-Productivity Linked Bonus (Ad-hoc Bonus) to all the Non-Teaching employees was sanctioned for payment for the year 2015-16 & 2016-17 vide office orders first & second cited.

The UGC vide letter No. F.25/4/2007(CU), dated 18-10-2017 communicated that the Govt. of India has not extended the orders of the Non-Productivity Linked Bonus (Ad-hoc Bonus) to the employees of autonomous bodies for the years 2015-16 & 2016-17 and if the University has already paid the bonus to their employees for the years 2015-16 and 2016-17, the University may make the recoveries from the employees concerned.

The Ministry of Education, Department of Higher Education letter third cited, directed to make a recovery, and to submit Action Taken by the University on observations/recommendations contained in the Sixty Second Report of the Public Accounts Committee (17th Lok Sabha on "Irregular payment of Ad-hoc Bonus")

Accordingly, vide office order 5th cited, it was conveyed to the Finance Officer to recover the amount of Non-Productivity Linked Bonus (Adhoc Bonus) from the salaries of such of the Non-Teaching employees including NMR employees for the year 2015-16 & 2016-17 as per the list, to who the Ad-hoc Bonus was paid.

The said list includes non-teaching employees who have subsequently either retired or expired. Therefore, it has been decided to effect the recovery from the Dearness Relief of future Pension/ Family Pension payments in four (4) equal installments with effect from the payable month of January 2025 so as to comply with the Report of the Public Accounts Committee.
