
Subject: Re- Constitution of Empowered Committee for Differently Abled Persons (ECDAP)- Reg

- i) The Tenure of the Committee is for two years from the date of issue of this notification i.e., with effect from 01.01.2025.  
ii) The coordinator shall nominate four student representatives on the Committee.  
iii) At least two student representatives should be present when the Committee takes any decision.

**The terms of reference of the committee shall be as under:**

- 1) To ensure the implementation of reservation of 5% of seats for admissions in the University in terms of Section 32 of the Rights of Persons with Disabilities Act-2016.
- 2) To formulate mechanism for orientation and sensitization at university level regarding rights of persons with Disabilities (PWDs) in terms of Section 39 (2)(d), and to ensure that the Rights of PWDs are included in the curriculum in University in terms of Section 39 (2) (9) (f);
- 3) To ensure providing inclusive education to children/students with disabilities in terms of the provisions of Chapter III of the PWD Act-2016.
- 4) To ensure implementation of other provisions of the Rights of Persons with Disabilities Act-2016
- 5) The Empowered Committee for Differently Abled Persons shall act as Need Assessment Board (NAB), Resource Unit (RC), and Enabling Unit for implementing Accessibility Guidelines and Standards for Higher Education Institutions and Universities issued by UGC.
