

Consequent upon his relief from the Yogi Vemana University (YVU), Kadapa, Andhra Pradesh, Dr. Phanithi Prakash Babu, Id. No.1281, Senior Professor, Department of Biotechnology & Bioinformatics, School of Life Sciences is permitted to assume charge as the Vice-Chancellor, Pondicherry University for a period of five years from the date on which he enters upon his office or until he attains the age of 70 years, whichever is earlier, without needing to report to the University of Hyderabad.

Further to state that his tenure of deputation/foreign service and retention of lien on his substantive position in this University shall be coterminous with the continuous tenure of Vice-Chancellorship in both Yogi Vemana University and Pondicherry University or his retirement from service in this University, whichever is earlier.

The pension contribution and leave salary contribution for the deputation/foreign service period have to be remitted by the Pondicherry University to this University as per the Govt. of India rules in vogue, as amended from time to time.
