

Instructions:

- Non-refundable Nomination Fee for each position is Rs. 300/- (*Rupees Three Hundred only*) for General Category students and Rs. 150/- (*Rupees One Hundred and Fifty only*) for SC/ ST/ OBC / EWS / PWD category students.
- All Candidates, Proposers and Seconders have to be full-time students with valid semester registration of the University.
- Duly filled nomination forms are to be submitted along with the required documents, and after depositing the nomination fee. In-complete nominations, in any form, will be rejected.
- No proxy will be allowed for submission of nomination forms and withdrawal forms.

Eligibility Criteria for Nomination

1. The candidate must be a full-time regular student with a valid semester registration of the University. Distance / proximate education students are not eligible to contest. Re-admission / Recourse / Research Scholars on extension are not eligible.
2. The candidate should be proposed and seconded by two students (with valid semester registration) who belong to the electorate of the position for which he/she is contesting.
3. A student can propose or second a candidate for nomination only once.
4. For the position of School Councillors, the proposer and seconder must be from the same School.
5. For the position of School Board (Research), the proposer and seconder must be a Research Scholar from the same School.
6. For the position of School Board (P.G), the proposer and seconder must be a Postgraduate from the same School.
7. The candidate contesting for any position must be from the electorate which will vote for that position.
8. The Integrated Students currently studying at the College for Integrated Studies are eligible to contest for the position of School Board Member- cum- Councillor belonging to the same stream for specialization have to file their nominations from the respective subject only i.e., **Social Sciences (First Three years), Humanities (First Three years), and Sciences (First Two years). NEP adopted courses, demarcation is as per the respective schools.**
9. The candidate shall not have a previous criminal record, that is to say, he/she should not have been convicted of any criminal offence or misdemeanor and should not have been subjected to any disciplinary action by the Proctorial Board/Disciplinary Committee of the University.
10. The Candidate should have 75% attendance in aggregate upto 10th September, 2025 (barring Foundation Course) in the current semester, which should be certified by the Head of the Department OR Dean of the School.


11. A candidate's academic arrears/backlogs, if any, have to be as per the University norms.
12. A student who has attained the age of 17 years (not born after 01.10.2008) and who has not completed 28 years (not born before 01.10.1997) years on the date of election notification is eligible to file nomination as a candidate for any position of Office Bearer.
13. Students who are enrolled for a second PG programme in the University are not eligible to contest. Similarly, Ph.D. scholars who are on extension are also not eligible to contest.
14. A student who has held any position of Office Bearer or School Board member or Councillor or ICC- (GSCASH) cannot contest for a position in the same category again, with the provision that a student who lost an election before can contest any position again.
15. Academic programmes are classified as under:
 - a) **Post-Graduate Programmes:** M.Sc, M.A, MCA, 5-year Masters (Integrated), Integrated M.Tech
 - b) **Research Programmes:** M. Tech, Ph.D, Integrated Ph D.,
16. If any candidate filing nominations for two or more positions, has to **keep** only one nomination for any one of the positions. Otherwise, candidature will not be considered for any of the positions.

1. **Legible Photocopy** of the Identity Card and Semester Registration Card for the semester July-December 2025 of the candidate filing nomination.
2. **Legible Photocopy** of the Identity Card and Semester Registration Card for the semester July-December 2025 of Proposer and Seconder.
3. Proof of Date of birth.
4. Certificate of Attendance and Academic Record.
5. Category Certificate (if applicable)

Withdrawal of Nominations:

- Withdrawal of the nomination can be made in the prescribed format at Office of the Election Commission on 13th September, 2025 from 2.00 pm to 4.00 pm by the Candidate only.

CODE OF CONDUCT FOR
STUDENTS' UNION ELECTIONS 2025 - 2026

1. Each candidate is allowed a maximum of thirty Posters and ten banners (size: 3' X 5') only and **no Posters and banners are allowed outside the University gates. Only cloth banners are allowed.**
2. The paper/cloth made posters and banners have to be approved and signed by the Election Commission. The posters and banners for campaigning should be in English, Hindi and Telugu languages.
3. Posters/ Writings/ paintings shall NOT be pasted on walls of the academic and residential buildings.
4. Maximum permitted expenditure per candidate is Rs.7,000/-. Each candidate shall submit complete & audited accounts to the DSW office within two weeks of the declaration of results.
5. **Candidate can use pamphlets for campaigning only after getting the express consent of the Election Commission. A copy of each pamphlet distributed needs to be filed with the Election Commission in advance.**
6. Candidates and voters shall abide by the norms of decent canvassing. Personal slander, including on social media, and defacing, tearing and pulling down of posters will result in invalidation of the candidature/s.
7. **No rally or processions are allowed.**
8. Candidates shall not disturb or enter any classroom without the permission of the faculty member concerned.
9. No outsider is allowed to campaign for the elections in any form. Political/Religious leaders are prohibited from addressing the students under any pretext during the entire election process.
10. The use of religious symbols or slogans as well as the use of names of any political party and social identity in banners, posters and pamphlets or any form of the campaign is strictly prohibited. The term political party refers to the list of political entities listed by the Election Commission of India.
11. **No candidate or supporter shall involve in any official canvassing or pamphleteering from 18th September, 2025 from 7:00 a.m. onwards.**
12. No candidate shall indulge in nor shall abet any activity, which may aggravate existing differences or create mutual hatred or cause tension between different religions, castes, communities, or between any group(s) of students.

13. Criticism of other candidates, when made, shall be confined to their policies and programmes, past record and work. Candidates shall refrain from criticism of all aspects of private life, not connected with the public activities of the other candidates or supporters of such other candidates. Criticism of other candidates, or their supporters based on unverified allegations or distortion shall be avoided.
14. There shall be no appeal to caste or communal feelings for securing votes. Places of worship, within or outside the campus shall not be used for election propaganda.
15. All candidates are prohibited from indulging or abetting, any activities which are considered to be "corrupt practices" and offences, such as bribing of voters, intimidation of voters, impersonation of voters in any form, canvassing or the use of propaganda within 100 meters of polling stations. They shall not hold any public meetings during the polling and counting process.
16. **On the Polling day, no candidate shall distribute, nor should any voter be in possession of any form of slips with candidates' name(s). Any violation will result in the disqualification of the voter found in possession of such material.**
17. No candidate or his/her supporters shall deface or cause any destruction to any property of the University, for any purpose whatsoever. All candidates shall be held jointly liable for any destruction of/defacing of any University property.
18. Except the voters, no one shall enter the polling booth. No Voter shall be allowed without a valid ID card issued by the University/ Election Commission. No Mobile Phones, Pens, Pencils, or smart watches will be allowed in the polling booths.
19. All candidates shall be jointly responsible for ensuring the cleaning up of the polling area within 48 hours of the conclusion of polling. If not, the university authorities will direct the concerned to clean up and necessary penalty will be imposed.
20. Any digital manipulations will be reported to the appropriate authorities for necessary action.
21. **Any violation of the above will result in invalidation of the candidature/s. The Election Commission/University authorities may also take appropriate disciplinary/legal action on any written complaints that are received in any regard.**




