

- ❖ The President or General Secretary of the Students' Union shall mandatorily take part in the ICC proceedings held to consider complaints involving students.
- ❖ The elected student members shall take part in the proceedings only if the matter involves students *as per sub-clause (1) (c) of Clause of 4 of the UGC (Prevention, Prohibition and Redressal of sexual harassment of women employees and students in Higher Educational Institutions) Regulations, 2015*. Their tenure shall be coterminous with the term of the Notification of the DSW for the Students' Union Elections in respect of ICC (GS-CASH) Members.

The Committee shall receive complaints on sexual harassment, adjudicate and make appropriate recommendations the Vice-Chancellor as per provisions of the UGC (Prevention, Prohibition and Redressal of sexual harassment of women employees and students in Higher Educational Institutions) Regulations, 2015.

Prof. Anuradha J., Presiding Officer (Outgoing) may hand over the charge and records to Prof. Lalitha Guruprasad, the Presiding Officer designate on or before 28<sup>th</sup> February, 2026.
