Sub: Closing of hostels and messes during summer vacation—regarding.

This is to bring to the notice of all the P.G/Integrated students (Outgoing/Ongoing) that the following hostel messes will be closed during summer vacation from **01/06/2026**.

- **Men's Hostels:** A&H, F&G, and I&L
- **Ladies' Hostels:** LH-VII&VIII

PG/Integrated students who have completed their programs/courses must clear their Mess Dues and vacate the hostel by **31/05/2026**.

1. Students pursuing programs that flow into the next semester shall be required to lock up their belongings in their room lockers/cupboards and shall not plan to stay in hostels during summer vacation beyond **31/05/2026**. Such of those students shall hand over the **room keys** to the respective Wardens Offices. They may carry lockers/cupboard keys with them.
2. Students who wish to appear for **NET/SLET/CSIR/Civil Services Examinations** and those who are staying back for academic purposes, such as **Internships/Projects/Summer Courses (in case of CIS students)** need to apply in **prescribed application form with undertaking** available in hostel offices or can be downloaded from the Chief Warden's website (<https://cwo.uohyd.ac.in>) with authorization from their respective Deans/Heads/Director etc. **on/before 25/05/2026 after clearing all their outstanding mess dues.**
3. No application shall be entertained after the **25/05/2026**. The filled in application forms need to be **submitted to the respective Wardens' Offices**. The name of the eligible students will be communicated to the respective hostel offices before **31/05/2026**.
4. The CWO shall not be in a position to consider applications for any other reasons. No requests for partial stay shall be entertained.
5. Mess facility will be provided at **MH-E (NRS), MH-J&K, LH-III, and LH-IX**.
6. The students who are permitted to stay shall pay a mess deposit of Rs. 2500/- is to be remitted to the hostel mess to which the student is attached. The period of stay in hostels during summer vacation is till **30/06/2026** (validity of semester).
